- Survey training needs assessment (IPSE 2006, TRICE 2010)
- Meeting of infection control training contact points (Udine 2010)

Our vision after TRICE



- Sharing experience and tools is seen as a priority
- Core competencies for infection control and hospital hygiene professionals could be used to review training materials
- Programmes and materials for training could be shared in common workspace (ECDC Extranet, wiki format)
- Web forum for trainers on infection control and hospital hygiene in Europe
- National contact points for infection control training in Europe may benefit from annual meetings, teleconferences, newsletters

Core competencies in infection control and hospital hygiene



- National contact points TRICE review IPSE core curriculum
- Two tiers or levels: foundational, expert, in several areas
 - Programme management
 - Quality improvement
 - Surveillance and investigation
 - Core infection control activities: implementing infection control and healthcare procedures, contributing to reducing AMR, advising appropriate lab testing, decontamination and sterilisation of medical devices and controlling environmental sources of infections



Editorial structure 2010






