Guide for adaption and distribution of ECDC policy briefings at national level

1. Introduction

The overall approach for the policy briefings is to provide information in a format that public health colleagues in the Member States can easily adapt for use with their own policymakers. Specifically, the format is designed to:

- provide a concise paper for the attention of policymakers and influencers;
- highlight a particular public health problem within an existing EU policy framework where ECDC is working;
- provide current information, presented in an action-orientated context, based on ECDC data as well as external sources;
- cover areas where economic evidence and best practice examples exist.

2. Adapting the policy briefing

In order to reach key decision makers in your country or region, it may be beneficial to translate the policy briefing or to add elements specific to your local situation. Adaptation and re-use are actively encouraged; it is permitted to translate or adapt the policy briefing without permission. However, if making changes to the content, the ISBN, catalogue number and doi should be removed as these are specific to the ECDC product.
